












Canada Travel - Typical Routes





Canada Travel - Did you Depart US?

- Yes, if you...
 - made landfall or anchored outside the US
 - made contact with a "hovering vessel"
 - disembarked goods or people, or
 - received merchandise "outside the territorial sea"



Entering Canada - Reporting Station Data

- Canada Reporting Stations on prior chart have:
 - Telephone Reporting
 - I-68 Permit *
 - NEXUS
 - CANPASS



Trusted Traveler Programs * **

^{*} Must apply & pay fees



Entering Canada - Telephone Reporting

- Arrive and secure boat at reporting station dock when the port is open for inspection *
- Captain <u>only</u> leaves the boat
 - Pick up telephone, wait for answer
 - Report names, birth dates, passport numbers for Captain and all passengers
 - Answer standard customs reporting questions
- Receive / post customs clearance # on boat
- * Bedwell Harbor is seasonal, others open 24 / 7 / 365



A Note on Passports for Children

- Travel.State.Gov says:
 - Children under 16 apply in person using Form DS-11 - Passports valid for only five years
 - Children age 16-17 "most" apply in person using
 Form DS-11 Passports valid for ten years
- There are multiple references that say US residents traveling internationally, even infants, must have a passport.
 These are in various articles

(http://traveltips.usatoday.com/age-usa-passport-required-105781.html). My brief search did not reveal any minimum passport age requirements on US government websites.

Returning US - In-Person Reporting

- Arrive and secure boat at reporting station dock when the port is open for inspection *
- Captain only reports in-person to customs officer
 - Report names, birth dates, passport numbers for Captain and all passengers
 - Answer standard customs reporting questions
- Receive / record customs clearance # in log
 - * 8AM to 8PM (mid May to Sept), otherwise 8AM to 5PM

Canada Travel - 1-68 Permit

- Apply at US Customs / Border Protection offices
 - \$16 per person / \$32 for families
 - Valid for one year
 - Bring proof of citizenship (passport, birth certificate, photo ID)
 - Vessel information helpful
 - Each person applying must appear

Canada Travel - Trusted Traveler Reporting

- Call between 30 min / 4 hours of arrival
- Provide vessel and passenger information:
 - ETA / Destination *
 - Vessel name / registration info / Decal # **
 - Trusted Traveler numbers, names, etc
 - Answer standard customs reporting questions
 - Receive / post customs clearance # on boat
- Arrive port / remain until ETA time is past ***
 - * A customs port when entering Canada
 - **If over 30ft entering US ***Canada only

Canada Travel - Standard Questions

- Do you have anything to declare?
- How much tobacco / alcohol?
 - "Bar Stock only" is a good standard answer
- Purpose of Trip
- Any animals?
- Any commercial goods?
- Any firearms or ammunition?
- Do you have over CAN \$10,000 ?







Canada Travel - You can take to Canada

- Personal goods
- Your mode of transportation
- Food must be declared:
 - Generous amounts for all food types
 - See "Limited" and "Not Allowed" charts



Entering Canada - Limited

- Alcohol: "Bar stock", otherwise, per person...
 - 53 oz wine or 40 oz liquor or 24 cans beer
- Tobacco: 200 cigarettes, 50 cigars
 - Must be stamped "duty paid Canada"
- Animals: Must be declared (includes pets)
- Firewood requires a permit
- Conifers and garden plants: Restricted

Entering Canada - Not Allowed

- Switchblades, most handguns, automatic weapons, pepper spray or mace
- Baked goods or candies containing meat
- Stone fruit or apples
- Potatoes
- Fresh Corn
- Marijuana...


Entering US - Limited

- Alcohol: 1 liter per person
 - Only if out of the country more than 48 hours
 - One exemption every 30 days
- Tobacco: Found no guidelines
- Fruits and vegetables grown in Canada are generally allowed if they are so labeled
- Must provide proof of origin of beef, pork, poultry, cervid meat and pet food



Entering US - Not Allowed

- Houseplants / firewood may not be allowed
- Products containing sheep, lamb or goat are prohibited (includes pet food)
- Fresh fruit / citrus
- Potatoes
- Tomatoes





Canada Travel - Duty Free Exemptions

- \$200 regardless of time away
 - Can include up to 50 cigarettes, 10 cigars,
 5oz alcohol or perfume containing alcohol
- \$800 if away at least 48 hours
 - May include one liter of alcohol
 - No mention of tobacco products

Cannot combine exemptions with other travelers

Canada Travel - For the Skipper

- VHF Radio Licenses
 - Station License required...
 - Over 65 ft vessel in US waters
 - Any length vessel outside US waters
 - **\$220, 10 years**
 - Restricted Radio Operators Permit
 - Foreign use of VHF radio
 - \$70, lifetime

Canada Travel - Odds & Ends

- Annual user fee on boats entering the US
 - 30' and over
 - **\$27.50**
 - Decal / Transponder Online Procurement System
 - Go to DTOPS website to purchase
- Access to cash / exchange rate
- No, a flare gun is not a "firearm" in Canada

Canada Travel - Source Material

- Radio Station License:
 - Apply online using the FCC ULS system
 - http://wireless.fcc.gov/uls/index.htm?job=home
 - Or call: 1-888-225-5322, Option 2
 - Form 159 for payment *
- Restricted Radio Operator's Permit
 - Schedule E of FCC Form 605 to apply
 - Form 159 for payment *
 - * Must submit separate Form 159 for each application
